Bidding will be conducted through the national competitive procurement using a Request For Bids (RFB) procedures as specified in the World Bank's <u>Procurement Regulations for IPF Borrowers</u> July 2016, revised November 2017 edition and is open to all eligible bidders as defined in the Procurement Regulations.
- 4. Interested eligible bidders may obtain further information from ECU-MoES and inspect the bidding documents during office hours 09:00 to 16:00 hours at the address given below.

- 5. A complete set of bidding documents in English may be purchased by interested eligible bidders upon the submission of a written application to the address below and upon payment of a nonrefundable fee of LAKI.500.000 equivalent at time of purchase. The method of payment will be in cash only. If there are any discrepancies in text, the text in the PDF format will prevail. The document will be picked up from ECU's office or sent via e-mail.
- 6. Bids must be delivered to the address below on or before 09:30 (Lao Time) of 22 February 2024. Late bids will be rejected. Bids will be publicly opened in the presence of the bidders' designated representatives and anyone who choose to attend at the address below at 09:45 (Lao Time) of 22 February 2024.
- 7. All bids must be accompanied by a Bid Security of USD8.000 or equivalent in Lao Kip, in the form provided in the bidding document.
