

## Invitation for Bids

The **Lao People’s Democratic Republic** has received a loan from the Asian Development Bank (ADB) toward the cost of **Second Strengthening Higher Education Project** and intends to apply part of the proceeds of this loan to payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
2. The **Ministry of Education and Sports, Department of Higher Education** (“the Employer”) invites sealed bids from eligible Bidders for the construction, completion and installation of the **furniture and fixtures** for the following buildings of the Savannakhet University New Campus:

**International Competitive Bidding (ICB)** will be conducted in accordance with ADB’s [Single Stage – One Envelope](#) procedure and is open to all bidders from eligible countries as described in the Bidding Document.

3. Only eligible Bidders with following key qualifications should participate in this bidding:
  - The Bidder shall furnish documentary evidence that it meets the following experience and financial requirements:
    - i. that the Bidder has successfully or substantially completed at least 2 (two) contracts within the last five (5) years and that are similar to the proposed works, where the value of the Bidder’s participation exceeds **USD2.9 Million** for each contract.
    - ii. that the Bidder has a Minimum Average Annual Turnover of **USD7.2 Million** calculated as total certified payments received by the Bidder for contracts completed or under execution over the last three (3) years.
    - iii. that the Bidder must demonstrate that its financial resources less its financial obligations for its current contract commitments meet or exceed the total requirement for the Subject Contract of **USD1.4 Million**.

- iv. that the bidder have at least 2 contracts in the last five (5) years that demonstrate experience on equipment installation or furniture interior design.

Bids will be opened in the presence of the Bidders' representatives and other interested person who choose to attend in person at the address below **on 30 August 2022 at 14:15 hours (local time)**.
8. The Employer will not be responsible for any cost or expense incurred by Bidders in connection with the preparation or delivery of bids.
9. In the comparison of bids, ADB's Domestic Preference is NOT applied.
